We comply with the principles of Responsible Care®, the FAO's* international code of conduct on the distribution and use of pesticides. However, we go beyond mandatory compliance to help farmers use our products in a more responsible way with due care for both human health and the environment.

■ Shared responsibility

We all share responsibility for product stewardship. It is incumbent upon all of us who are part of the product lifecycle – manufacturers, retailers, farmers, and waste disposers – to work together to reduce any environmental impacts associated with the use of our products.



■ Research & Development

Our R&D-process is focused on solving real problems that farmers encounter. Apart from developing new active ingredients, we enhance existing products through improved formulations, packaging and delivery.

We constantly work to develop innovative products that are biologically efficient, environmentally sound, user-friendly and economically viable. This requires time and considerable investment – to bring a new product to market takes eight to ten years and costs around €200 million.



■ Manufacturing

Safety underlines everything we do. Environmental protection, health and safety are priority values and core business principles. Our involvement in the chemical industry's Responsible Care™ program reinforces the importance we place on corporate social responsibility and sustainable business practices in Environmental Protection, Product Stewardship, Occupational Health and Safety, Process Safety, Distribution Safety, Communication, Security and Emergency Response.



■ Storage, transport and distribution

The storage, transport and distribution of our product is important. We demand high standards from our suppliers that exceed the industry norm and conduct regular audits to ensure compliance. We provide extensive training to our transport contractors, distributors and retailers. In the event of any accident, rapid response plans are in place.



■ Safety on the farm

The correct packaging plays an essential role in the safe delivery of our products from our factory to their final point of use on the farm. We use

prominent, easy-to-understand symbols and pictograms on our labels and screw caps, which help to transcend language and literacy barriers. This minimizes the risk of instructions being ignored, mislaid or misunderstood.

BASF promotes the use of personal protective equipment and supports regular safety training for farmers, distributors and agricultural advisors.

One of the biggest problems on the farm is how to safely dispose of empty product containers. We listened carefully to farmers to understand their concerns. In response, we pioneered a closed-transfer systems, the multi-use Ecomatic®, which ensures safe and easy handling of crop protection products throughout the mixing, loading and rinsing phases.

As part of our strong commitment, we also work with associations and governments to implement container disposal and recycling programs around the globe.
